## Legacy

---

Much before the concept of Corporate Social Responsibility had evolved into its present form, Atul Ltd (Atul) has been engaged in serving the society with diverse initiatives in the fields of education, health and infrastructure. Mr Kasturbhai Lalbhai, the Founder of Atul and an Indian legend, ensured complete commitment to community development and welfare in every company he established. The primary reason for the establishment of Atul was to generate large scale employment and consequently improve the standard of living in rural India. His passion to give back to the society was reflected in his daily schedule; he spent half a day on growing businesses while the other half was dedicated solely to social service. He appointed Mr Balwantraoi Mazumdar, an economist and Mr Siddharth Lalbhai, his elder son and a chemical engineer, to develop Atul, both of whom continued with the fine legacy.

In 1978, Mr Siddharth Lalbhai laid the foundation of Atul Rural Development Fund in an endeavour to further the rich legacy of his father and bring focus to rural development projects undertaken by Atul. He personally oversaw each project which was being implemented and took keen interest in consistently improving the quality, variety and impact of such projects.

Over the years, with an increase in the number and scope of projects related to serving the society, Atul Foundation was established in 2010 as an umbrella trust of Atul.

## **Kasturbhai Lalbhai (1894 - 1980)**

The legacy of Mr Kasturbhai Lalbhai has been synonymous with three terms in the broadest sense: excellence, perseverance and trusteeship.

## **Balwantrai Mazumdar (1902 -1981)**

An economist, Mr Balwantrai Mazumdar was a voracious reader, sound thinker, patient listener and a farsighted professional. He created an atmosphere of camaraderie that brought out the collective best in the people of Atul. He was the moving force behind making the first site of Atul one of the largest eco-friendly manufacturing facilities of its kind in the world. He remained with the Group till the end of his life as did most of the people who worked with Mr Kasturbhai Lalbhai.

## **Siddharth Lalbhai (1923 - 1998)**

A chemical engineer and the elder son of our Founder, Mr Siddharth Lalbhai dedicated his life to the development of Atul. He accorded equal value to creation of wealth and service to society. The principles of trusteeship that he upheld, the personal qualities of integrity, perseverance and simplicity that he lived by and the single-minded devotion that he gave to tasks on hand will always remain our guiding force.

# Chairperson's foreword

---

Dear All,

I am happy to present the Annual Report 2019-20 of Atul Foundation Trust.

Just when 2019-20 was about to end, COVID-19 pandemic scripted a new chapter in the life of human beings and has since forced new normal ways of living. The pandemic, amongst others (such as simplicity, minimalism, hygiene and exercise), has taught us that strengthening villages and making them self-reliant (*atmanirbhar*) is the way forward for India. Atul Foundation in its own small way is working in villages to unravel their potential.

During 2019-20, Atul Foundation continued with the initiatives to provide quality education - Atul Adhyapikas created significant change in reading, writing and basic arithmetic capabilities amongst children of class 1 to class 4. Students of Atul Vidyamandir made themselves and their school proud with their achievements in sports, fine arts and academics - they won many state and national level medals. Throughout the year, life skills training was imparted to teachers of all the institutions. The Foundation trained 1,139 tribal youth in various vocational courses apart from imparting training to 161 farmers in beekeeping. 500 individual household toilets were built in 15 villages of Gujarat. 5,807 patients from 30 interior villages of Gujarat were treated through 44 eye camps and health camps along with blood donation camps. 3,633 students from 13 schools and 321 women of nearby villages were given treatment for anaemia and made aware about the disease. In response to COVID-19, it distributed 3,887 grocery kits to daily wage earners and needy people from 25 villages. Face masks were stitched and donated to corona warriors and NGOs. It developed 17 Model Anganwadis in seven villages and renovated a school and hostel to provide better infrastructure to the students from rural areas in and around Atul. In an endeavour to protect the environment, it planted 40,211 trees.

It also took special initiatives to pay tribute to the legendary Founder of Atul, Mr Kasturbhai Lalbhai on his 125<sup>th</sup> birth anniversary.

In the present uncertain times of the pandemic, Atul Foundation is committed to protect health and well-being, particularly of those less fortunate. It is working on developing large number of Poshanwadis in villages, building Model Anganwadis and implementing household solid waste management projects in villages to create sustainable impact on the lives and livelihoods of rural communities. It contributed ₹ 3 cr to the PM CARES Fund and ₹ 2 cr to the Gujarat Chief Minister Relief Fund to complement the mighty efforts of the government.

On behalf of Atul Foundation, I wish to express gratitude to all the supporters and well-wishers.

## Kalyani Shala

Established: 1953

Managed: Atul Kelavani Mandal

About: Kalyani Shala is a private aided school providing quality and affordable education to children belonging to *Atul* and surrounding villages. It offers classes from kindergarten to 12 and the medium of instruction is Gujarati. Currently, it has 1,802 students.



## Urmi

Established: 1953

Managed: Atul Foundation Trust

About: Urmi empowers women by providing them with sustainable livelihood opportunities. Production of spices was introduced in the early 1960s; over the years, sun dried and iron pounded spices prepared using age-old traditional practices have evolved as the identity of the organisation. The complete process from sun drying to roasting, pounding, blending and packaging is managed by women from surrounding villages.



## Ulhas

Established: 1961

Managed: Atul Foundation Trust

About: Ulhas promotes health and well-being of residents of *Atul* and surrounding villages. It organises cricket tournaments, inter-village volleyball competitions and marathons.







### Utkarsh

Established: 1965

Managed: Atul Foundation Trust

About: Utkarsh provides a platform to promote social and cultural programs for residents of *Atul* and surrounding villages. It organises music and dance competitions, annual funfairs and cultural events.



### Atul Vidyalaya

Established: 1991

Managed: Atul Vidyalaya Trust

About: Atul Vidyalaya is a private unaided school providing quality education to children belonging to *Atul* and surrounding towns | villages. It offers classes from kindergarten to 12 and the medium of instruction is English. Currently, it has 1,241 students.

### Atul Club

Established: 1995

Managed: Atul Club Trust

About: Atul Club provides quality sport and recreational facilities to residents of *Atul* and surrounding towns | villages. It offers facilities for badminton, billiards, swimming, table-tennis and also has a well-equipped gymnasium.



### Atul Vidyamandir

Adopted: 2009

Managed: Atul Vidyalyaya Trust

About: Atul Vidyamandir is an Eklavya model residential school that operates under the Public Private Partnership (PPP) model with the Government of Gujarat. It caters only to the tribal students and also provides them with residential facilities. It offers classes from 6 to 12 and the medium of instruction is Gujarati. Currently, it has 359 students.



### Atul Institute of Vocational Excellence

Established: 2011

Managed: Atul Rural Development Fund

About: Atul Institute of Vocational Excellence is a vocational training center that operates under the PPP model with the Government of Gujarat. It imparts skills to tribal boys and girls in various vocations and also provides them with employment opportunities. So far, 7,843 tribal students have been trained of whom about 75% have been placed.



### Industrial Training Institutes

(Khergam, Sagbara, Ankleshwar and Bilimora)

Adopted: 2011 and 2017

Managed: Atul Ltd

About: The Industrial Training Institutes (ITIs) in Khergam, Sagbara, Ankleshwar and Bilimora operate under the PPP model with the Government of Gujarat. The ITIs offer courses for a duration of one to two years in a range of vocations.



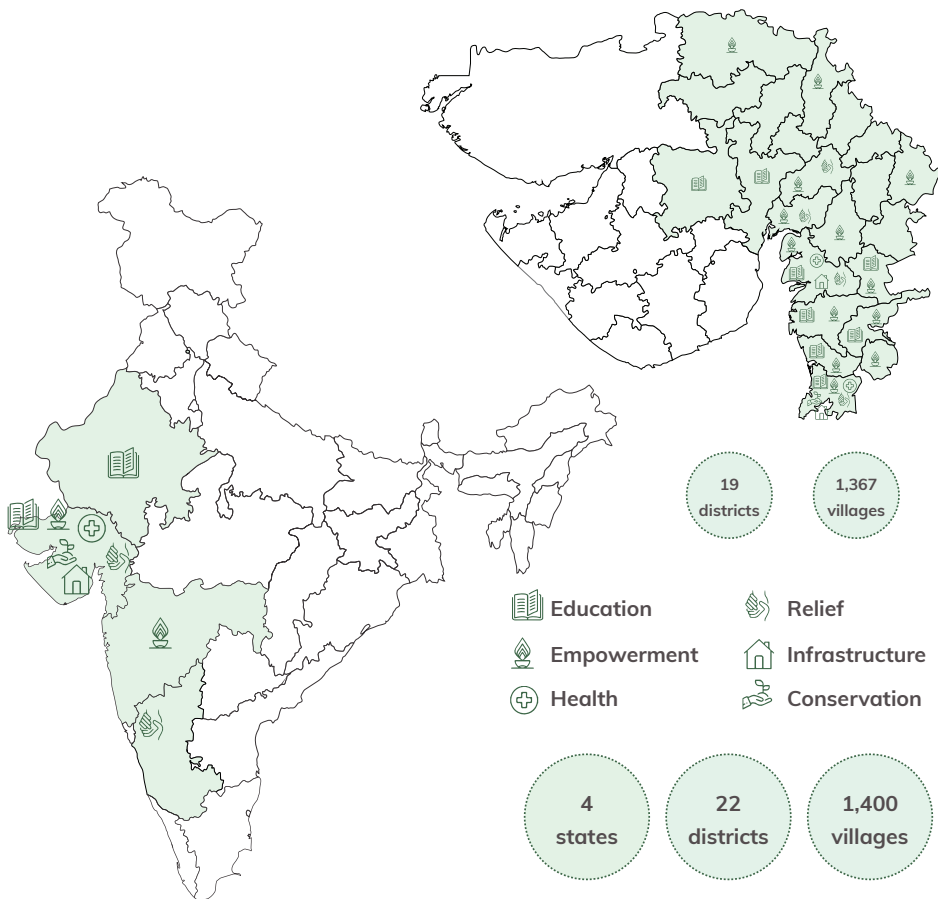


# Footprint

# Response to COVID-19 pandemic

Through these uncertain and testing times of COVID-19, Atul Foundation has stepped up its support to different communities. It has gathered resources and skills to stand by the lesser privileged, migrant workers, front line community workers and the government. The Foundation responded to the crisis in the following ways:

## **Preventive | protective measures to combat COVID-19**

Atul Foundation ensures that health and safety remain its primary focus in all actions that it undertakes in response to COVID-19 pandemic.

**Protection through mask:** Atul Institute of Vocational Excellence has lent its support and strength by stitching over 1,00,000 masks. 24,200 masks have been donated to protect *anganwadi* workers, female health workers, ICDS staff, blood banks, NGO volunteers and individuals. The masks are being stitched by the rural women trained by the institute. The user-friendly masks are also available for individuals at low rates.







**Awareness drive:** Education and awareness among the communities is the key step to fight against COVID-19. Atul Foundation is constantly trying to remain in touch with its 3,424 students, more than 300 teachers and ground level staff members. The Foundation provides education and awareness to team members through virtual medium. It ensures that all the team members are aware about the safety guidelines. 84 Atul Adhyapikas from interior locations are running awareness campaigns in their own villages and contributing their bit to fight against COVID-19. The Foundation has educated over 20,000 students, parents and youth on protective measures against COVID-19 and on building immunity.



## Relief measures to support needy

**Contribution:** Atul Ltd has contributed ₹ 3 cr to PM CARES Fund and ₹ 2 cr to Gujarat Chief Minister Relief Fund to support the government to manage the crisis.

**Ensure availability of ration:** Many migrant and unorganised sector workers lost their source of earning due to sudden lockdown announced in the country. The Foundation has supported 3,887 families from 25 villages by providing them grocery kits. All the precautions and guidelines were followed during the process of making and distributing kits.



**Support to migrant workers:** The Foundation has assisted the migrant workers to reach their native place safely. They were also provided with water and refreshments to sustain them during their long journey back home.

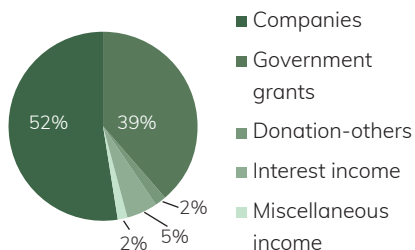

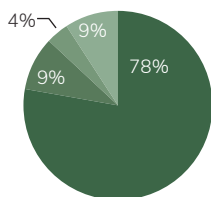

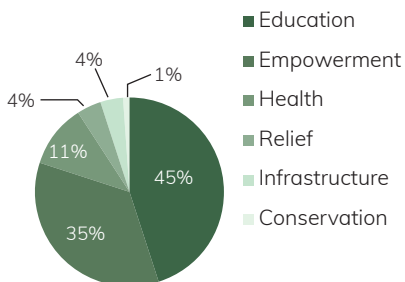
